

# SUSTAINABLE FOREST MANAGEMENT: March17.- 20.2016, Milverton, Somerset, UK

## Announcement

Sustainable forestry is one the topics Forum Synergies is focusing on and we are happy to announce the first in a planned series of four workshops.

After an inaugural meeting in 2012 a small working group started to plan the activities and set up a workplan. This group brought together representatives from 4 countries who agreed a programme to deliver four workshops based around the following **topics**:

- (1) To raise **awareness** of the different services provided by sustainable forest management (United Kingdom)
- (2) To analyse **strategies** of how forests can be a lever for local development in rural communities (Germany)
- (3) To share experiences of how rural communities are involved in looking after woodlands (Sweden)
- (4) To give local actors and authorities better **access** to practical knowledge about sustainable forest management (France)

What we want to reach:

- (1) To understand and communicate what sustainable forestry means in practice.
- (2) To disseminate the EU Forestry Strategy amongst practitioners and civil society.
- (3) To help formulate realistic, complementary and consistent **policies in and between member states**.
- (4) Propose actions and recommend support.

We have identified so far these **main elements** which are important factors in the context of sustainable forestry and which will have to be taken into consideration in the process of discussions:

- Sustainable management across the main European forest types (Mediterranean, Central European, temperate, Scandinavian)
- Dissemination of good practice at stakeholder level
- State Action Plans and programmes
- Member state coordination/cooperation/consistency at the stakeholder level and where appropriate try to link up rural development funding between and across state boundaries to improve consistency of management, sustainability and communication
- The role of forests at the heart of Europe's Green Infrastructure and in delivery of the 2020 Biodiversity Strategy
- Promotion of woodland and wood products and the communication of forestry benefits to decision makers and civil society.
- The cultural role of woodlands to communities and in the landscape
- The role and importance of small woodland owners
- The development of information systems
- Climate Change mitigation
- Forestry policy coordination at the National and European levels
- The impact of forests as a source for "green electricity", renewable resource
- The "access to forests" as un upcoming conflict between big companies and small owners.

#### Main objectives of the 1st workshop

The ultimate aim of the Forum Synergies project is to increase the capacity and ability of individuals, NGOs, local and EU governments to deliver forestry management that is economically, socially and environmentally sustainable.

The first workshop in the UK will set the scene by examining what is meant by sustainable forestry. It will raise awareness for the wider benefits of sustainable forestry management and the services it provides apart from timber production, like e.g., climate change mitigation, flood control, biodiversity aspects, landscape values, forests as recreational space for people as one of the social functions forests provide. All these aspects will promote discussion and exchange of good and/ or innovative practices. The second day will be dedicated to creating a common vision of sustainability, services and current policies. We will contrast these findings with the goals and impacts of current national policies and the EU ForestryStrategy.These findings will enable us to find a common understandingand make proposals for activities on EU, national and regional/ local level.

The main elements will be:

- (1) Immersion in local realities (field trips)
- (2) presentations from other countries on the main issues of the workshop
- (3) link between local experiences and policies (national and European)
- (4) working groups to formulate proposals on 3 levels
  - options for activities in the participants' own regions
  - for policy makers
  - for the next workshops

## Venue

We are happily looking forward to our upcoming meeting on SUSTAINABLE FOREST MANAGEMENT we will meet in the county of Somerset in South West England.

The region is rich in examples of the work of national organisations and other local initiatives such as the Forestry Commission's Ward Forester scheme which is an attempt to bring management to woodlands that receive no management. Others include significant land owners like the Clinton Devon and the Ilchester Estates who have an excellent understanding of the natural environment and how their forestry operations can be improved through sustainable management practices. Additionally the Sylvanus team in Devon and Cornwall has long championed sustainable management to reinvigorate native woodlands.
